- The participant will have to attend the judging session in person on the 3rd JULY 2022. Screening time will be informed to the participants once the presentation is shortlisted.
- The Commentary/Voice-over can be done live-in-person or can be pre-recorded.
- Selected films/presentation as chosen by the Judges will be screened at the Giritra Samsamela - subject to availability of time.
- If drone Camera was used for filming, the participants are required to fill in a declaration for the same (See the attached declaration)
- Equipment like Laptop, Multimedia Projector and sound system will be provided by the Organization. If any other specific equipment is needed, please discuss with the organizers.
- Final selected participants will get entry only for attending the Study based presentation (i.e. Last session 2:30 pm to 4:00 pm on 10th July 2022). If he/she desires to attend the entire Giritra Samsamela then he/she has to obtain donation pass of Giritra Samsamela.

5. All the entries sent for this competition must be original work of the participant. He / she should keep the raw footages, rushes, original photographs ready - if asked by the Judges.
